THE PARTIES TO THIS AGREEMENT ARE CHRISTIANS AND BELIEVE THAT THE BIBLE COMMANDS THEM TO MAKE EVERY EFFORT TO LIVE AT PEACE AND TO RESOLVE DISPUTES WITH EACH OTHER IN PRIVATE OR WITHIN THE CHRISTIAN CHURCH (SEE MATTHEW 18:15-20; 1 CORINTHIANS 6:1-8). THEREFORE, THE PARTIES AGREE THAT ANY CLAIM OR DISPUTE ARISING FROM OR RELATED TO THIS AGREEMENT SHALL BE SETTLED BY BIBLICALLY-BASED MEDIATION AND, IF NECESSARY, LEGALLY BINDING ARBITRATION IN ACCORDANCE WITH THE RULES OF PROCEDURE FOR CHRISTIAN CONCILIATION OF THE INSTITUTE FOR CHRISTIAN CONCILIATION, A DIVISION OF PEACEMAKER® MINISTRIES (COMPLETE TEXT OF THE RULES IS AVAILABLE AT WWW.PEACEMAKER.NET). JUDGMENT UPON AN ARBITRATION DECISION WILL BE CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF MISSOURI, EXCLUDING ANY CONFLICT-OF-LAWS RULE OR PRINCIPLE THAT MIGHT REFER THE GOVERNANCE OR THE CONSTRUCTION OF THIS RELEASE TO THE LAW OF ANOTHER JURISDICTION. THE PARTIES UNDERSTAND THAT THESE METHODS SHALL BE THE SOLE REMEDY FOR ANY CONTROVERSY OR CLAIM ARISING OUT OF THIS AGREEMENT AND EXPRESSLY WAIVE THEIR RIGHT TO FILE A LAWSUIT IN ANY CIVIL COURT AGAINST ONE ANOTHER FOR SUCH DISPUTES, EXCEPT TO ENFORCE AN ARBITRATION DECISION. SHOULD A PARTY DECIDE TO BRING A LAWSUIT DESPITE THE BINDING ARBITRATION CLAUSE; THE PREVAILING PARTY WILL HAVE ALL ATTORNEY FEES PAID FOR BY THE NON-PREVAILING PARTY.
